## Meeting Minutes Phoenix, Maricopa County December 16, 2003

#### **COMMISSION MEMBERS PRESENT**

#### 1. CALL TO ORDER.

Chair Eisenhower called the meeting to order at approximately 10:05 a.m.

**3. RULES** (discussion and action).

Mr. Mehnert said that the only outstanding suggestion is that there be an opening post hearing memorandum, a response memorandum, and a <u>reply memorandum</u> to the response memorandum. Mr. Mehnert indicated that in the past the Commission has considered the opening post hearing memorandum and response memorandum to be sufficient. Mr. Mehnert indicated that if there are no additional suggested changes in the rules the Commission will go forward with the Notice of Final Rulemaking before the end of the year.

7. ATTORNEY CONTRACT CONTINUATION (discussion and action).

It was recognized and discussed that the attorney should receive a greater hourly rate, but that budget shortages will prevent an increase.

**8. BUDGET AND REPORT FROM DIRECTOR** (discussion and action).

Director reported condition of budget and potential need for infusion of additional funding for FY2004, FY2005, and FY2006 to speed up Commission's work and be able to pay for appeals.

9. CAUSE NUMBER CONSOLIDATION (discussion and action).

A discussion ensued with the goal of insuring that any testimony or other evidence received during a hearing regarding a major watercourse will be considered by the Commission regarding the entire major watercourse. The example was given by attorney Curtis Jennings that there will be six separate hearings in six Arizona counties regarding the Gila River and that if someone submits evidence regarding the Gila River in a particular county that evidence should apply to the entire watercourse to the extent it relates to the entire watercourse.

The Commissioners decided that any consolidation of cause numbers to facilitate insuring all evidence submitted for any portion of a watercourse is Considered by the Commission for the entire watercourse is an administrative matter and should be resolved by the Chair and the Director.

### 11. FUTURE AGENDA ITEMS AND ESTABLISHMENT OF FUTURE HEARINGS AND OTHER MEETINGS.

A hearing meeting was established for March 9, 2004 in Florence, Pinal County Arizona regarding the Small and Minor Watercourses in Pinal County, the Gila River, the Santa Cruz River, and the San Pedro River.

A discussion occurred regarding whether oral arguments by parties would be permitted as an agenda item regarding the determination of the navigability of the Lower Salt River scheduled for a meeting on January 27, 2004. The Commissioners indicated that oral arguments before a vote have not been helpful in the past because the Commissioners had already reviewed the evidence and read the post hearing memorandums. The Chair indicated that he would probably move the consideration of the Lower Salt River to the last watercourse item on the January 27, 2004 agenda.
