SOME ARTICHOKEs—In the window of the W. K. James real estate office there is a plant which has attracted a great deal of attention for the last two days. COME ON YOU PIE BUILDERS

Novel Contest Will Decide Who is the Best Pie-Baker in the Valley, and Three Lucky Mortals Will Receive Cash Prizes

Ever hear of a "Pie Contest"? Not a pie eating contest; but a sort of an exhibition of pies where the baker of the best, second best and third best pastry masterpieces receive valuable prizes and the onlookers become the happy possessors of all the pie which the judges do not demolish in the course of their official duties. So far as is known such a contest is a novelty to Phoenix; but it will not be after next Tuesday. On that day all the master bakers, or bakersesses in the valley are invited to submit the choicest specimens of their handiwork to a board of competent judges, to be passed upon, inspected and eaten.

There are certain conditions attached to the contest which must be observed. The fillings, "works" or insides of the pies must be made from a fruit now in season and grown in the Salt River Valley. Plums, cherries, peaches, apricots, grapes, strawberries, blackberries, raspberries and loganberries will fill the bill.

The maker of the best pie will receive ten dollars in gold, to the maker of the second best pie will be given a five dollar gold piece and the maker of the third best bit of pastry will receive two dollars and a half in coin of the realm.

Contestants forfeit all right and claim to the pies upon entrance of same in contest. They become the property of the onlookers and will be properly cared for by them.

No entrance fee, other than the regular admission at the gate, will be charged.

The contest will take place at Riverside Park next Tuesday evening, July 13, and it is open to every amateur piebaker in the valley. Entries close at noon on the day of the contest. The hour of the judgment and general distribution of the pies will be announced later.

GARBAGE INSPECTIONS—City Health Officer Godfrey yesterday announced that the special sanitary officers engaged in making inspections of garbage and manure are meeting with success in their work of directing the citizens generally to provide adequate receptacles. Dr. Godfrey urges that all citizens, when directed to do so by the inspectors or not pay close attention to their garbage cans to see that they are covered and to their barn yards to see that manure does not accumulate.

LIKES PHOENIX—George C. Wood, head of the department of biology of the Commercial high school of New York City, stopped off in this city a day or two ago, to take in the "light" and incidentally to pay a visit to Land Attorney Arnold Mandl, a brother of whom is an instructor in the same school as that to which Mr. Wood is attached. Mr. Wood stated yesterday that he is much surprised and pleased with this section of Arizona, and especially gratified with the hospitality shown him here. He will continue on his way to the expositions, taking in the Grand Canyon enroute.

NEW ROAD SURFACING

It is reported that an experiment is being made with a material which heretofore has been a waste product of glass factories, for road-making. This is a thick, syrupy liquid that hardens when exposed to the atmosphere, forming a substance that somewhat resembles glass. A quantity of this material is mixed with crushed stone and used to surface a stretch of highway in Illinois, forming a surface that is as smooth as concrete. How this surface will stand up under weather and wear will be watched with interest.

CITY'S VALUATION DECREASES AND SO DOES THE TAX RATE

With a decreased assessable valuation of city property about \$2,000,000, compared with that of 1914, when the valuation amounted to something over \$29,000,000, the city tax rate for the ensuing year, as indicated by the budget approved by the city commission in special session yesterday, will be fixed at 85 cents, as compared with \$1 on each \$100 valuation last year. In the face of greatly reduced receipts by reason of the liquor licenses being wiped out and the mercantile licenses so greatly reduced that they will amount to about one-sixth of the amount collected last year, the commission and City Manager Robert A. Craig believe that it will be conceded that this material reduction in the tax rate is an accomplishment to which they may well point with pride.
