WATER USERS COUNCIL

Institutes a Movement for Priority Agreement Among Land Owners.

There was an all day session yesterday of the council of the water users association, devoted mainly to consideration of plans for an agreement or stipulation for the purpose of facilitating the settlement of the priority suit. The forenoon was devoted to a report of the subcommittee which held a meeting previously for a similar purpose to listen to plans prepared and simplify action. The subcommittee reported two proposed plans, one presented by Frank Parker and the other by C. B. Wood.

The afternoon was devoted to a discussion of these plans after which resolutions were passed authorizing further action and which are given below. The Parker plan which had been submitted at the meeting of the subcommittee was further elucidated so that when considered yesterday it covered four large typewritten pages. It cannot be reproduced at this time except by brief reference as follows: It is based on the general admission that there are 750 quarter sections or 120,000 acres in the valley that are first entitled to water up to the measure of their needs, before other lands. Assuming that the plan is signed by all the owners of these lands the plan stipulates that pending the adjudication of the Hurley-Abbot suit the owners of these 750 quarter sections agree among themselves that the water supply whatever it be shall be prorated to their lands at any stage of the river up to the full measure of the appropriations belonging to these lands. That for the purpose of carrying out the stipulation the records of the Wormser case against the north side canals and the data collated by the water storage commission, shall be the basis for the determination of the location of the said 750 quarter sections. It suggests that matters would be facilitated if this area entitled to first flow could be reduced to 700 quarter sections to be designated as class A lands and that class B lands could include all other lands in the valley that have had occasional irrigations and that the owners of such lands could enter into a similar agreement. This would include 400 or more quarter sections which would be entitled to water after class A had been served. Then follow certain from the "Kibbey table" showing watered acreage, location, etc., and suggestions concerning details of the plan, which of course should be read in full and understood before either adopted or condemned by the reader of this article.

The plan of C. B. Wood was similar but more brief as to detail and like the other can only be referred to here. It suggests first that the Tempe and San Francisco continue to get water as at present under the Kibbey decision. That it be understood by all other land owners that forty inches is a maximum need for a quarter section and that the lands be divided into four classes, A, B, C and D, according to priority of filings. That the owners of all classes agree to a stipulation on these lines and share equitably the cost of settling the priority litigation.

After a discussion of the two plans it was evident that it would take a great deal of careful deliberation to work out in detail an acceptable plan that would do justice to all. The sense of the council was therefore expressed in the adoption of the following resolution:

Resolved: That in the judgment of this council a concerted effort should at once be made to unite the owners of cultivated lands both within and without the association, on some form of an agreement as to the use of the natural appropriated flow of the Salt and Verde rivers. Said agreement to be used as a stipulation in the suit of Hurley versus Abbot, et al., and to be binding upon all parties signing such agreement.

It is further resolved that to secure prompt action along the above lines we urge the immediate organization of a committee of sixteen composed as follows:

1. The president of the association.
2. The vice-president of the association.
3. The secretary of the association.
4. Seven members appointed from the council.
5. Three members appointed from the board of governors.
6. One representative of the lands under the Tempe canal not in the association.
7. One representative of the lands under the San Francisco not in the association.

Said committee to prepare without delay a plan of agreement and stipulation for presentation to the owners of cultivated lands.

It will be observed that several members of the committee authorized above are yet to be appointed and the council instructed that they should be named jointly by Mr. Fowler, president of the association and C. T. Hirst, chairman of the council.

Attention was also called to the fact that the above resolution seemed to favor the cultivated lands as against the uncultivated lands, which of course was not the purpose as it is desired to do equal justice to all and recognize all established rights, there being no desire to create any new schism or give ground for any lack of harmony. In view of this the above resolution was amended, modified, or better explained by the following:

Said committee shall be empowered to work out a comprehensive plan for all the lands within the association, if in their study of the situation they find such a plan feasible."
