In Yolo and Sutter they have the best crop in ten years yield, 25 bushels. In Yolo county the price is 1 25 @ 135. There are about 170,000 acres of grain in Monterey county acres of grain in Monterey county this year. Three fourths of which is wheat and the remainder barley and mustard, chiefly barley. The average yield will be about ten centals per acre. Probably one half of the wheat yield will be of good quality, and the other half more or less shrunken. Wheat harvest is just commencing in the Salinas Valley. commencing in the Salinas Valley. Wheat market has opened at Sesmi Tchama county, at \$1 25 per cetal.
