Tucson, April 8, 1891. There is more building and fixing up going on in this old pueblo than for many years past. First the foundation is fixed by cutting away about half the thickness of the adobe and replacing it with cut stone nicely lined up and carried down into the ground some depth. You may have observed, if not look at any adobe house or wall, and you will see how it is cut by the moisture near the ground. Putting in this stone preserves it. After the foundation is done, then a plaster is put on, colored to represent any stone you may prefer. This plaster is marked by cutting lines to represent stone. 
